1. The agreed purchase price is R..... and the Buyer(s) have agreed to pay a deposit of R1 000,00. Should the Buyer(s) cancel the agreement or fail to take delivery of the puppy for whatever reason, monies already paid to the Breeder (Seller) will be retained in lieu of expenses incurred such as re-advertising and good home selection, interviews with other prospective purchasers, maintenance expenses and veterinary care until the puppy is sold to another acceptable Buyer.
2. The Breeder (Seller) has ensured that they have taken every care that the puppy is of pedigreed stock in accordance with the Official Breed Council of KUSA, and that the puppy is believed to be such.

3. The Buyer(s) agree to collect the puppy , being in a healthy condition at the time of collection, at a minimum of seven and a half to eight weeks of age.
4. This agreement is free of all warranties expressed or implied.
5. The Buyer(s) examined the puppy and noted that there are no defects of any nature whatsoever. The Breeder (Seller) gives no warranty and the Buyer(s) shall not be entitled to seek any relief under this agreement whether directly or indirectly arising from any latent defects as may manifest itself during the lifetime of the dog.
6. In this connection the Breeder (Seller) specifically points out to the Buyer(s) that the Rottweiler breed has a tendency towards Canine Hip Dysplasia (CHD), and while both parents conform to the minimum breed requirements in this respect as stipulated by the Rottweiler Breed Council of KUSA, the Buyer(s) acknowledge the possibility that this condition might occur in this animal. The Breeder (Seller) is liable to hand over the puppy in perfect health.
7. Copies of the Certificates of Registration of both parents of said puppy will be handed to the Buyer(s) on collection of the puppy. The KUSA Certificate of Registration of the puppy will be forwarded to the address of the Buyer(s), per registered mail, as soon as said document is received by the Breeder (Seller) from the Kennel Union of South Africa (KUSA).
8. The Buyer(s) agree to the following:
  - That there is a need to have a dog of this potential size undergo formal training at an acceptable training facility from the age of six months, for at least six months.
  - To have this puppy x-rayed for CHD at the age of 18 months.
  - That should the Buyer(s) wish to sell or transfer the ownership of the dog, to allow the Breeder (Seller) first option.
  - That should the Breeder (Seller) wish to use a male for stud purposes, the Buyer(s) shall permit him to do so, for a regular stud fee.
  - Any breeding will be done according to the rules and code of ethics of the Rottweiler Breed Council of KUSA.
  - That should the dog develop into a prime show specimen, the Buyer(s) will undertake to show it, or if not, allow the Breeder (Seller) to do so.
9. **Docking of Tail**

The Purchaser acknowledges and accepts that, in terms of the Breed Standards as put down by the ADRK-Germany as the country of origin for the breed, the docking of tails are prohibited by law and the tail should be left natural. **Under no circumstances, save as set out below, may the tail of the Puppy be docked without the express written consent of the Seller first having been obtained.**

Should injury to the tail cause it to become necessary to dock the tail, whether wholly or in part, and in the opinion of the veterinarian treating the Puppy, the Purchaser shall notify the Seller forthwith who shall be entitled to

obtain a second opinion from a veterinarian of his choice to confirm the diagnosis and make a recommendation. In the event of a dispute between the two veterinarians, the opinion of the Seller's veterinarian shall take precedence.

In the event of the Purchaser being in breach of the terms of the docking restriction set out above, the parties agree that the Seller will incur damages in the agreed liquidated amount of R50 000-0000 (Fifty Thousand Rand), as a direct or indirect result of the Purchasers conduct. In addition the Purchaser shall be liable to pay punitive damages in the amount of R100 000-00 (One Hundred Thousand Rand) to the Seller or the animal anti-cruelty association of the Seller's choice. The Seller shall be entitled to recover the abovementioned amounts from the Purchaser notwithstanding any other remedies that the Seller may have.

10. No party shall be bound by representation, warranty, promise or the like not recorded herein.
11. This document constitutes the sole record of the agreement between the parties and no additional to, variation of or consensual cancellation of this agreement shall be of any force of effect unless in writing and signed by or on behalf of the Buyer(s) and Breeder (Seller).
12. The Breeder (Seller) relies on the integrity of the Buyer(s) to honor this agreement.
